FINANCIAL

Finance Report

Management and Administration

Staff reported:

- CDBG Mitigation Planning Grant Update: The Healthcare Coalition Alliance (18 counties) submitted a grant application to Florida DEO to fund a healthcare project known as the "North Florida Resiliency Plan for the Health and Medical Lifeline." The grant application was selected for conference and further review by DEO staff. Coalition staff gave a presentation and answered questions from DEO staff at the end of September. We await further correspondence and the status of this project application.
- **Virtual Training** HCC staff has been working with providers to offer virtual training. Staff will release training courses and registration links following the New Year.
- ASPR Funding COVID-19 Preparedness & Response Activities: The Northeast Florida Regional Council, contract manager for the Region 3 Healthcare Coalition Alliance (18 counties) has entered into an agreement with Florida Hospital Association on being a recipient of a grant to address COVID-19 preparedness and response activities. The intent of this money is to identify, isolate, assess, transport, or treat patients with COVID-19 or other special pathogens or infectious diseases. The NEFRC is currently selecting a vendor to complete an infectious disease mitigation strategy.

BUSINESS

Approval of New Member Requests

There were two new member request for this month.

Final COVID-19 After-Action Report/Improvement Plan

Staff of the Alliance provided a review of the COVID-19 After-Action Report/Improvement Plan including an overview of Healthcare Preparedness and Response Capabilities and their associated objectives and activities, which were used as the evaluation standard for the COVID-19 activation. Staff presented the report in October, comments were gathered, and the final AAR-IP was presented for consideration and approval.

The Chair called for a motion of approval of the After Action Report for COVID-19. Ms. DeKay moved approval; Mr. Taylor seconded. Motion carried.

FY 2020-21 Project Funding Update

All MOAs have been distributed to the organizations with approved projects. Currently the Center fo Independent Living and Gainesville Fire Rescue has signed and returned these MOAs. The deadline for all signed agreements is January 8, so the process is far ahead of schedule.

All training and exercise activities are postponed due to COBID-19. Monthly meetings will continue using the Zoom platform.
