CALL TO ORDER

Welcome

The Chair welcomed members.

Approval of Minutes

The minutes from May 2022 were provided to Board members via electronic mail and June Meeting Packet.

The Chair called for a motion of approval. Mr. Ferguson moved approval; Mr. Long seconded; Motion carried.

FINANCIAL

Finance Report

Leigh Wilsey presented the finance report for May 2022.

The Chair called for a motion of approval. Ms. DeKay moved approval; Mr. Long seconded; Motion carried.

Expenditure Requests - None

Management and Administration

- **Final Expenditures:** Staff report wrapping up final purchases that do not need Board approval. Report they are purchasing training materials such as projectors. Staff reiterates the redirection of funds from a canceled CHAMP project to a Northeast facility that was discussed last month.
- **New contract with FDOH**: Staff reports new contract from FDOH is still awaiting budget approval from the State. Report an increase in funding with the contract. The new board members from all three Coalitions will be invited to review what the Alliance is and the new changes with the contract.
- Year-end Review and Plans for Next Year: Wrapping up contract year 21-22, the Alliance provided about 35 trainings with 430 attendees, and was able to fund, along with FHA, approximately \$261,000 on member projects/equipment. Planning for next year, there will be more engagement with marketing and member retention processes. For training, planning for NIMS, HICS & NHICS, Active Assailant, and EOP/COOP plan writing workshops. For exercises, planning for Pediatric Surge tabletop, Radiation Surge tabletop, and CMS Compliant tabletop. This next year the Alliance is also planning to sponsor members to attend EMAG in Savannah.

BUSINESS

New Members

Nine (9) new member requests were presented for membership.

The Chair called for a motion of approval of the members. Mr. Ferguson moved approval; Mr. Long seconded; Motion carried.

*Final Plan Approvals

Staff report they received valuable feedback and comments on the Preparedness Plan, Infectious Disease Plan, Supply Chain Mitigation Strategy, and Mass Fatality Surge Plan. Staff integrated all the appropriate changes to the documents and thanked the members who took the time to provide a thorough review.

The Chair called for a motion of approval of the members. Mr. Long moved approval; Ms. DeKay seconded; Motion carried.

TRAINING AND EXERCISE

Stress First Aid

Staff reported over the past two weeks, 25 people across the State and 3 people within the Alliance received Stress First Aid train-the-trainer, training. These individuals can now provide Stress First Aid training to members and facilities. More to come on future train-the-trainer offerings.

Tania Glenn – Virtual Training: Resiliency Through Chaos

First Coast Disaster Council and the Alliance sponsored a virtual presentation by Dr. Tania Glenn on June 21st at 11:00 AM. More to come on how to access the recording of the presentation

MRSE Exercise – June 23 (partnering with FCDC)

Staff reported that Thursday, June 23rd, is the MRSE exercise following the FCDC meeting. This exercise will surge the Duval County hospital and bring key stakeholders to the table to discuss processes if this event ever did occur.

INTRODUCE & INSTALL NEW BOARD MEMBERS FOR 2022-2024

Mr. Lyons introduced the new board members for 2022-2024. As he is rotating off the Board, Mr. Lyons thanked the members for allowing him to serve on the Board. He commented on the growth in membership and the benefits of the activities conducted by the HCC during his tenure. Staff thanked those exiting the Board for their time and dedication to the Coalition.

Staff asked the new Board members to consider an officer position on the Board. With not all Board members present, staff will send an email requesting Board members express interest in the Board officer positions. Due to the challenges of fuel costs and the geographic area of the HCC, staff proposed moving to virtual, monthly Board meetings with a quarterly, in-person General Membership meeting.

MEMBER REPORTS AND OPEN DISCUSSION

Hospitals – UF Health Gainesville reported COVID inpatient admissions have increased. Report the severity of illness is not as high. Report staff has an increased awareness of healthcare violence considering the recent stabbing and shooting. Reports their facility is using this awareness to fully evaluate their security programs.

Emergency Management – Nothing to report.

Public Health – Mr. Moffses reported they have been approved and received funding to purchase a mobile oxygen unit for Region 2; report it will take about a year to get delivered. State for COVID-19 data, go to: flhealthCOVID19.gov, this website is updated every 2 weeks. States they are looking at trends and still getting bell-curve spikes, with no large numbers with this variant. Report this difference in numbers is probably due to at-home testing, with no reporting to the health departments. Closely watching monkeypox, report the closest case to the Region is in Orange County.

EMS – Matt Ferguson from Dixie County EMS reported medication supply chain issues have gotten better. Report they are having supply chain issues with their equipment (stretcher batteries, etc.). Still

awaiting delivery of the truck, they ordered in September.

Home Health – Nothing to report.

Long-Term Care – Nothing to report.
