FINANCIAL

Finance Report

Staff presented the finance report for March and April.All current expenditures are normal and customary. Professional Services includes the virtual training services and our marketing services. We

will see more charges in this category as our vendors complete their projects. Project funding is also being reimbursed as members complete projects. This category should begin to decrease as members complete their projects.

The Chair called for a motion to approve the March and April Finance Reports. Ms. DeKay moved and Mr. Taylor seconded. Motion carried unanimously.

Management and Administration

- CDBG Mitigation Planning Grant Project Update: Coalition staff provided an update on the status of the CDBG Award. NEFRC is currently working through the contracting process with the Department of Economic Opportunity. It is the intent of NEFRC to have a finalized contract in place over the Summer and to begin implementing the program in Fall of 2021.
- **Final Year-End Deliverables:** HCC staff are diligently working towards the end of the State fiscal year, which ends on June 30. Several items will be brought to the June General Membership Meeting for review and approval by the Executive Board.
- **Project Close-Out:** The Coalition is in the process of reimbursing projects awards. It has been a slow process this year and we are encouraging members to submit their final paperwork. Projects must be closed out by June 30.
- Resume in-person meetings: HCC Staff discussed the opportunity to begin in-person meetings in July. The intent is to continue to offer a Zoom option for those that cannot travel to Gainesville. The consensus of the Board was to resume the in-person option, so staff will begin to look for a location.
- **2021 Florida Legislative Session Healthcare Recap:** Staff provided members with a handout on the legislative activities that related to healthcare.

BUSINESS

Approval of New Member Requests

There were four new member requests for this month.

The Chair called for a motion to approve the new members. Ms. DeKay moved approval and Mr. Taylor seconded. Motion carried unanimously.

<u>Draft Infectious Disease and Supply Chain Strategy Plans</u>

HCC Staff has provided four (4) draft documents to membership for review. Staff will take comments and recommendation for the next few weeks before making final changes. Final drafts will be presented to the Executive Committee for their review and approval at the June General Membership Meeting. The plans include:

- Alliance Supply Chain Mitigation Strategy & Appendices

Training and Exercise

The Alliance is sponsoring tabletop exercises in the first week of June. The Troubling Trajectory tabletop uses a hurricane scenario. The demand for these exercises was so great and additional dates have been added. All four sessions are sold out and a waiting list is in place.

The Alliance offered Hospital Incident Command Awareness course. Due to the continued high demand fo this course, staff will research the possibility of offering this course again in the near future.

Monthly meetings will continue using the Zoom platform.

CLOSING REMARKS AND ADJOURN

Staff reported that a project from the Northeast HCC will benefit other members. Jacksonville University created a video training for LTC culinary staff. The video will be available on the Alliancve Training website. The Center for Independent Living will alter its project to develop a podcast series for all members. More information to come for this project.
