CALL TO ORDER

Approval of Minutes

The minutes from April 2022 were provided to Board members via electronic mail and May Meeting Packet.

The Chair called for a motion of approval. Ms. DeKay moved approval; Mr. Smith seconded; Motion carried.

Finance Report

Leigh Wilsey presented the finance report for April 2022.

• **2021-2022 Project Funding Update & Closeout:** All projects have been completed for this fiscal year. Staff reported attending an HCC meeting on May 17, 2022, in Tampa, FL, and stated there was discussion on the planning for the new contract for 2022-2024.

BUSINESS

New Members

Six (6) new member requests were presented for membership.

The Chair called for a motion of approval of the members. Mr. Smith moved approval; Mr. Moffses seconded; Motion carried.

Elections for At-Large Board Member nominations (Ballots released)

Staff reported nominations have been received. Emergency Management is to remain Ralph Smith; Hospitals is to remain Suzanne DeKay; Public Health is to remain Tom Moffses. Staff reported a Long-Term Care nomination, but the contact information provided was not valid, they are working to contact the individual. Ballots have been emailed out and are due by Friday, June 3rd. The ballot includes voting for the EMS discipline and the At-Large Representatives.

2022-2023 Project Funding Applications Received

Staff reported applications were due and received by noon on May 16th. Staff will submit the projects to FDOH for approval. As in previous years, there will be a prioritization committee that will score the projects. The Board will approve this priority list and then wait until the final FDOH budget and contract. Staff reported receiving a total of 18 projects, from 15 different organizations. The cumulative total amount of all the projects is about \$320,000.

*Final Plan Approvals

Staff report they received valuable feedback and comments on both the Crisis Standards of Care Guidance Plan and the Burn Surge Annex. Staff integrated all the appropriate changes to the documents and thanked the members who took the time to provide a thorough review.

The Chair called for a motion of approval of the members. Ms. DeKay moved approval; Mr. Andrews seconded; Motion carried.

Plan Updates, Review, and Comment

Attached to the meeting packet are the plans that require annual updating: Preparedness Plan, Infectious Disease Plan, and Supply Chain Mitigation. Staff asked for review and comment to be returned by June 3rd.

Mass Fatality Surge Plan Review & C

Mass Fatality Plan was drafted by staff to serve as a resource guide and is attached to the meeting packet. Staff asked for review and comment for the Mass Fatality Plan to be returned by June 3rd.

TRAINING AND EXERCISE

Hospital Incident Command/Nursing Home Incident Command Training

Staff report there was a good turnout for the four training courses provided last week and this week, in various locations to benefit the Alliance. Planning has begun for the next fiscal year's training opportunities.

MRSE Exercise – June 23 (partnering with FCDC)

Partnering with First Coast Disaster Council (FCDC) in Jacksonville, the exercise is scheduled for June 23. The exercise asks for a surge of 20% of the staffed beds in the Region. Staff asked hospital members to look out for a survey that will be sent to them. This survey will ask for the hospital's current staffed capacity for bed types. Staff will use this data to build out the scenario for the exercise.

MEMBER REPORTS AND OPEN DISCUSSION

Hospitals – UF Health Gainesville reported COVID cases have been light at their hospital. Report they are currently working on their internal response plan for a scenario of highly infectious disease, following their participation in the FIDTN. Report they are also reviewing their internal active shooter response plan.

Emergency Management - State they are preparing for hurricane season to commence.

Public Health – Mr. Moffses reported earlier this week they had a productive meeting with the State with all Region 2 Planners. Report a good dialogue in general and planning for the upcoming hurricane season.

EMS – Nothing to report.

Home Health – Report working with patients and their families in preparation for hurricane season and signing patients up for the special needs registry. Report an uptick in COVID cases among their staff members, therefore they are increasing precautions within the facilities and encouraging staff to take precautions outside of work.

Long-Term Care – Nothing to report.

Center for Independent Living – Report their most recent Alachua County Expo went well, with almost 50 attendees and 14 vendors. Mr. Towles also stated that they will come to individual counties and provide education on how to work with people with disabilities.

Supply Chain Issues – Ms. DeKay reported that their hospital (UF Health Gainesville) has seen shortages in saline, contrast, etc., reported they are able to find the supplies from other vendors and make substitutions. Report they also have a lab onsite that can compound. Mr. Ralph Smith reported they have been unable to acquire the ambulances that they ordered last year; they were told not to expect the ambulances until August 2023.
