CALL TO ORDER

Approval of Minutes

FINANCIAL

Finance Report

Treasurer, Mr. Long, presented the finance report for February 2022.

Management and Administration

- Introduce New Staff Member: We are happy to introduce our new staff member, Annie Sieger. She will be working with the Healthcare Coalition Program. Please welcome Anie.
- **2021-2022 Project Funding Update:** All projects are in process. All projects are on target and in the process of purchasing and reimbursement. The CILNCF Disability Expo will be held in the spring and reimbursed immediately afterward.
- **FIDTN Exercise:** Staff reported that the Statewide Florida Infectious Disease Transportation Network, FIDTN, Exercise is March 24. The FIDTN is that State's plan to transport a highly infectious (e.g., Ebola) patient using a 'daisy chain' approach across Florida and then transfer the patient to Georgia EMS for final transport to the Region Treatment Center at Emory. Alachua County EMS and UF Shands will participate in this exercise for the Region. This exercise is good practice for hospital and EMS stakeholders.
- **EMAG:** The EMAG Conference will take place in Savannah, GA April 13-15. The Coalition has 13 members signed-up to attend. Still have additional funding to support more members to go. Staff encourages long-term care providers to consider attending. The HCC will pay for the conference registration, hotel for 3 nights, and parking. Attendees are responsible for transportation to Savannah, time, and meals/incidental expenses. Anyone interested in attending should email Leigh Wilsey.
- Board Member and Officer Terms: Staff reminded the Board members that their terms will expire June 30, 2022. Members that represent a discipline should contact their discipline group to determine if they will be reappointed or a new member appointed. In April, staff will request nominations for the At-Large Member positions. Nominees will be elected at the May meeting followed by a request for nominations for officers. In the June meeting, the new Board members will be installed, and the new officers will be elected. Tom Moffses will remain in Public Health.

BUSINESS

New Members

Five (5) new member requests were presented for membership.

2022-2023 Project Funding Presentation

Staff discussed the Regional Project Funding Application process. Applications must describe the project's alignments with the (HPP) and at least meet one of the four Health Care Preparedness & Response Capabilities. Preference is given to Regional projects and applications that align with specialty surge events. Demonstrated the submission forms.

Burn Surge Annex Draft

Staff reported that the Statewide HCC Working Group is working on a planning draft for a regional Burn Medical Surge event. This draft will be provided to the membership for review in comment in the near future. The HCC will participate in a FEMA virtual tabletop exercise for Burns on April 12, 2022.

TRAINING AND EXERCISE

<u>Virtual Training</u>: The schedule of virtual classes for March 2022 is posted to the statewide training website. <u>https://www.floridahcc.org/training/</u>

<u>Virtual Tabletops (VTTX)</u>: The VTTXs will be offered on 3/25, 3/30, and 4/5. Registration is now closed for the offerings. Seats are still available in the 4/5 offering, let staff know if you are interested in registering. The scenario will be a supply chain shortage and consideration for crisis standards of care.

<u>In-Person Training and Exercise</u>: First COOP scenario in-person TTX was today in Gainesville. St. Johns County 4/19 offering is full. Duval County 4/20 offering has several seats open, let staff know if you are interested in attending. HICS and NHICS classes are being scheduled with dates and locations pending. Registration information coming soon.

MEMBER REPORTS AND OPEN DISCUSSION

CILNCF, The Marion Expo will be 3/30/2022 and the Alachua Expo will be 4/14/2022. Attendees need to pre-register for the event. Staff will provide the flyer and link to register again in an email.
