Welcome

The Chair welcomed members.

Approval of Minutes

The minutes from December 2021 were provided to Board members via electronic mail.

FINANCIAL

Finance Report

Staff presented the finance report for December 2021.

The Chair called for a motion of approval. Ms. DeKay moved approval; Mr. Taylor seconded; Motion carried.

Management and Administration

- **2021-2022 Project Funding Update:** All projects are in process. One project recipient has already requested reimbursement. All projects are on target to be completed by the January 31 deadline, except for the Disability Expo, which will be held in the spring. This extension was pre-approved by staff.
- Meeting and Training Venues: Staff is searching for venues to host upcoming training sessions. Options
 include Gainesville Hall of Heroes, Gainesville Regional Utilities (GRU), Santa Fe College, Haven Hospice,
 Alachua County Health Department. Mr. Moffses suggested we consider the Hospital Authority building
 in Columbia County.

BUSINESS

New Members

Two (2) new member requests were presented for membership.

The Chair called for a motion of approval of the members. Mr. Smith moved approval; Ms. DeKay seconded; Motion carried.

FIDTN Exercise

Staff reported that the Stateside Florida Infectious Disease Transportation Network, FIDTN, Exercise has been postponed to March. The FIDTN is that State's plan to transport a highly infectious (e.g. Ebola) patient using a 'daisy chain' approach across Florida and then transfer the patient to Georgia EMS for final transport to the Region Treatment Center at Emory. Alachua County EMS will participate in this exercise for the Region. Staff will contact key partners, as needed, for controller/evaluator volunteers.

MRSE Exercise

Staff reported that the required Coalition Surge Test (CST) Exercise is now called the Medical Response and Surge Exercise (MRSE). This exercise has been postponed until May or June. Staff will provide updates as planning continues.

TRAINING AND EXERCISE

<u>Virtual Training</u>: A new schedule of virtual classes for January 2022-March 2022 has been posted to the statewide training website. https://www.floridahcc.org/training/

<u>Virtual Tabletops (VTTX)</u>: The VTTXs will be offered on 3/25, 3/30, and 4/5. The scenario will be a supply chain shortage and consideration for crisis standards of care. Registration details coming soon.

<u>In-Person Training and Exercise</u>: A COOP scenario in-person TTX will be scheduled in Gainesville (Date pending), St. Johns County 4/19, and Duval County 4/20. HICS and NHICS classes are being scheduled with dates and locations pending. Registration information coming soon.

MEMBER REPORTS AND OPEN DISCUSSION

Kevin Towles, CILNCF, thanked the Board for funding the upcoming Expo. He offered for members to have vendor tables at the event. Billie Adkins, Community Hospice, offered to help support the event.

Jeff Taylor, ACFR, reported that Joey Malphurs is retiring. Captain Sarah Weed will be replacing him.

Suzanne DeKay reported that hospitals continue to have staffing challenges, but during the Omicron surge, they did not exceed their surge capacity. Healthcare testing requirements continue to provide challenges.

Ralph Smith, Gilchrist EM, stated that they do not have any tests in the county.

Alachua EMS has recently seen a decrease in calls and staffing numbers are improving. Alachua County has changed its testing policy and not testing staff weekly.

CLOSING REMARKS AND ADJOURN

The Chair announced the next meeting will be a Board of Directors meeting on February 23, 2022 at 1:30. This meeting will be a hybrid meeting; both in-person and Zoom options. The in-person meeting will tentatively be held at Haven Hospice in Gainesville. Masks will be required for anyone that plans to attend. The same link will be used for all meetings.
