### **FINANCIAL**

### Finance Report

Staff presented the finance report for June 2021. The June report shows the closeout for the 2020-21 fiscal year. The budget shows it was overspent by \$33.25. It is a common practice to over spend this budget to ensure all monies are spent. This additional expense will be covered by the NEFRC budget.

The Chair called for a motion of approval. Mr. Smith moved approval, Ms. DeKay seconded; Motion carried.

### Management and Administration

- Region 3 Healthcare Coalition Alliance: Staff provided an overview of the Alliance geography and
  member healthcare coalitions. The North Central Florida HealthCare Coalition is one of three coalitions
  in the Alliance and our elected officers represent our interest on the Alliance Executive Board.
- **Annual Workplan:** Staff provided an overview of the 2021-2022 annual workplan and contract expectations with FDOH. There are several actions items including the development of new plans, continued project funding for members, and training and exercise opportunities.
- Infectious Disease Working Group: FHA has entered into a contract with the Northeast Florida Regional Council to address infectious disease planning in the healthcare sector. The Coalition will be convening an infectious disease workgroup to develop strategies to implement across the region in the coming year.

### **BUSINESS**

#### New Member Requests

There were three new members accepted into the membership of the NCFHCC.

The Chair called for a motion of approval. Ms. DeKay moved approval, Mr. Andrews seconded; Motion carried.

#### Project Funding FY 2021-2022

The project funding cycle is currently open. Staff, using ReadyOp, has distributed application packages and guidance to all members in the Region 3 Healthcare Coalition Alliance. Applications are due by July 26, 2021. All projects are expected to be completed by January 31, 2021. #### National Healthcare Coalition Preparedness Conference

The national conference will be hosted in Orlando on December 1-2, 2021. The Coalition has set aside funding to send up to four (4) members of the Coalition to the conference. The Coalition will pay for the conference registration, hotel and parking. The estimated cost is \$735.00 per attendee. The attendee is responsible for all other costs to attend. Staff will survey Board members for interest in attending.

The Chair called for a motion of approval to sponsor 4 members to attend the conference. Ms. DeKay moved approval, Mr. Andrews seconded; Motion carried.

#### **Training**

The annual training and exercise plan will be released in August. It will be a blend of virtual and in-person classes. All events will be dictated by COVID-19.

Staff has begun planning for the annual training symposium. We look to implement changes this year to accommodate the entire region and to vary our delivery to members. A framework will be presented to the executive board before moving forward.
