Approval of Minutes

FINANCIAL

Finance Report

Staff presented the finance report for September 2021. The report shows the usual and customary expenses Project funding will begin to decrease as projects are completed and reimbursements requested.

Management and Administration

- New Staff Member: Staff introduced the new NEFRC staff member Monica Dominguez. She will be working on the CDBG-Mitigation Grant Project. While not part of the HCC, this program will develop a plan to provide resiliency in the Health and Medical Lifeline. We look forward to working more closely with Monica during this 3-year program.
- Potential Infectious Disease Pilot Projects:
 - EMIST sprayers: The HCC will survey the pilot embers to ask for feedback as they use these sprayers. The plan is to extend this project. County EMS agencies are under consideration as recipients for this equipment.
 - Ventilated Headboards: Haven Hospice is participating in a pilot project to build ventilated headboards to be used as temporary isolation beds. They will collect data on the assembly of these units to determine if this is feasible to offer to other long-term care members.

BUSINESS

New Members

Two new members requests were presented for membership.

The Chair called for a motion of approval of the members. Ms. DeKay moved approval; Mr. Long seconded; Motion carried.

Bylaws Approval

Staff reported the proposed changes that were provided to the Board members for review. While offering members the opportunity to attend meetings virtually, a request was made to include language of the importance of Board members attending the meetings in-person.

Board Vacancies

Staff reported that the EMS discipline is currently vacant. Staff is working with the EMS to select a representative.

2021-22 Project Funding Update

All projects are in process and are scheduled to be completed on time.

Presentation

Julianna Gordon provided a presentation about a supply chain solution named bbtn. The bbtn service is available to all Coalition members with no contract required. A copy of the presentation is attached.

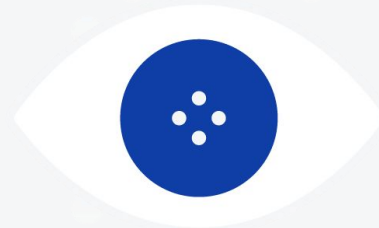

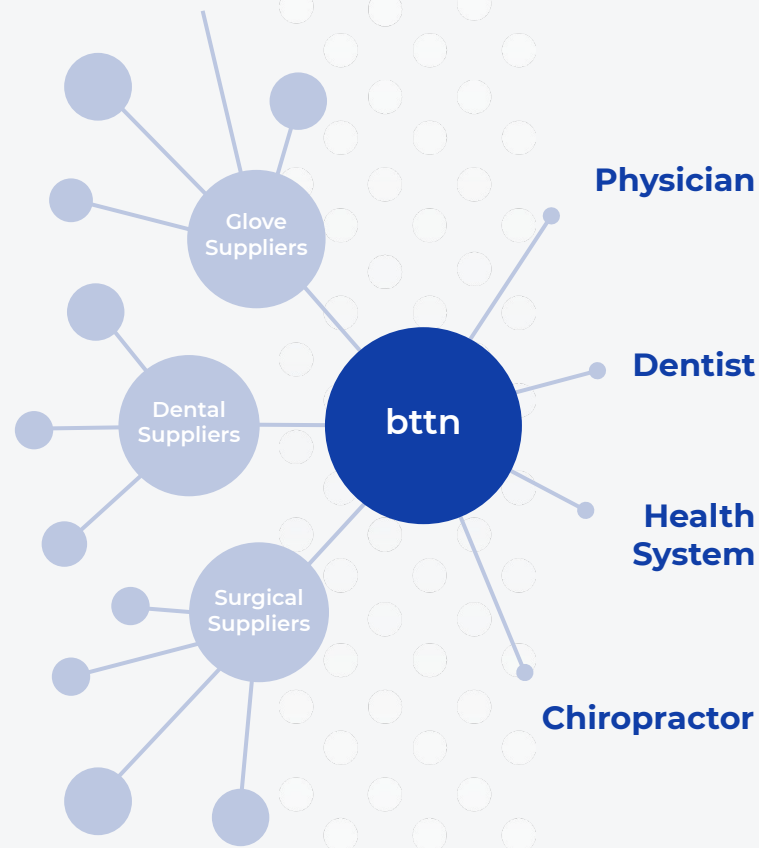

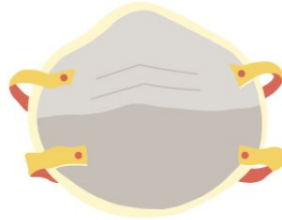

Case Study



Nancy is a Director of Nursing at a major skilled nursing company in Massachusetts. Nancy fell into a PPE procurement role over the pandemic. She oversees procurement of N-95s for 11 facilities.



She's looking to give purchasing power back to her individual facilities and get back to what she does best...



Pain Points

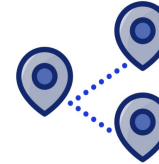
1) Due to federal single-use mandates, Nancy needed more masks on a consistent basis for each of her 11 facilities.



2) Each location needs to bill to the centralized billing location with different payment methods.



3) Nancy typically ships to one centralized location, then distributes those shipments to each of the 11 locations.



4) Nancy was worried about giving her facilities procurement autonomy without oversight.

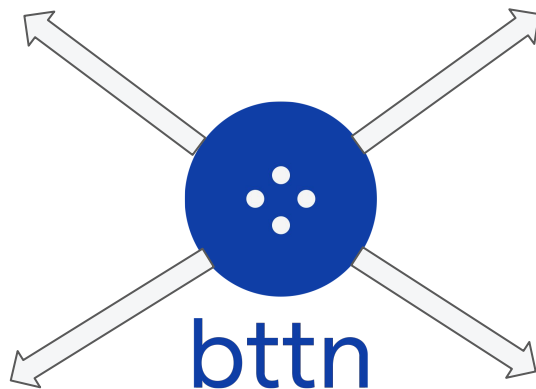


Solution 1

Nancy created a bttm. account and set up 30 day subscriptions to each of her locations. She can edit orders based on demand.

Solution 3

Each subscription order was set to ship to the 11 individual locations so Nancy doesn't have to worry about distribution.



Solution 2

Each location had the bill sent to the centralized location with flexible paying terms.

Solution 4

Nancy has admin access to all subscriptions and can make changes to all orders if necessary.



Today, each of Nancy's locations has their own account and all purchasing is automated. bttm lets Nancy know when prices are decreasing and what to expect on her next billing cycle.



Now Nancy can get back to what she does best...saving lives.
