Staff reported:

- PPE packages have been shipped to the requesting LTC facilities and home health agencies...
- Staff previously presented the CDBG: Mitigiation Grant application to the members. The NEFRC staff presentrf the application to the review panel. Staff was not given a timeline on the decion-making and will continue to update the Board as the process continues.
- Blueprint Creative Group, Fabiola, was once again awarded the marketing firm agreement. She will begin working on the Training webpage that will be used for online training opportunities.
- The Northeast Florida Regional Council, contract manager for the Region 3 Healthcare Coalition Alliance (18 counties) has entered into an agreement with Florida Hospital Association on being a recipient of a grant to address COVID-19 preparedness and response activities. The intent of this money is to identify, isolate, assess, transport, or treat patients with COVID-19 or other special pathogens or infectious diseases. The Alliance would like to create an Infectious Disease Working Group with 2-3 representatives from each Coalition. This working group will develop recommendations for long-term goals for the region. Kickoff meetings for the Infectious Disease Working Group will begin after the New Year

BUSINESS

FY 2020-21 Project Funding Update

All MOAs have been distributed to the organizations with approved projects. Currently the Center fo Independent Living and Gainesville Fire Rescue has signed and returned these MOAs. The deadline for all signed agreements is January 8, so the process is far ahead of schedule.

Draft COVID-19 After-Action Report/Improvement Plan

Staff of the Alliance provided a review of the COVID-19 After-Action Report/Improvement Plan. Staff gave an overview of Healthcare Preparedness and Response Capabilities and their associated objectives and activities, which were used as the evaluation standard for the COVID-19 activation. Staff gave a presentation on the first half of the AAR-IP in October, followed by the last half during this meeting. Comments will be gathered, and the final AAR-IP will be presented for consideration and approval at the December 2020 General Membership Meeting.
