

### Management and Administration

- **EMAG 2023** 18 individuals expressed interest and approval by their agency/organization to attend EMAG Savannah 2023. ### **Alliance Radiation Annex**

Staff thank all members who provided feedback and review of the Alliance Radiation Surge Annex. After review of the comments and suggestions, staff have updated the Annex and will upload the finalized version to the Alliance website.

### 2023 Alliance Operational Plan

Staff report they have made updates to the 2023 Alliance Operational Plan, as part of the contract deliverables. The updated Operational Plan was disseminated to the membership, and review/feedback was provided to staff. The finalized 2023 Alliance Operational Plan will be uploaded

to the Alliance website.

### **HVA Gaps Project**

The Alliance Board has identified pre-hospital pediatric surge management to be a prioritized, regional gap. The State has approved the Coalition's request to use the additional HVA gap funding to purchase equipment to help fill this regional gap.

### TRAINING AND EXERCISE

### <u>Virtual TTX Offerings</u>

Two offerings of an active threat virtual tabletop exercise will be provided through the Coalition on May 8<sup>th</sup> and May 16<sup>th</sup>. Both offerings will be from 1:30 PM to 4:00 PM. The flyer and registration information will be distributed to the Alliance membership soon.

### Statewide Radiation Surge Tabletop Exercise

In partnership with the State and the HCCs across the state, there will be a virtual, tabletop exercise on May 17<sup>th</sup> from 9:00 AM to 1:00 PM, to test the new Alliance Radiation Surge Annex. This statewide exercise will provide the opportunity for regional breakout groups for each region to discuss their threats, capabilities, and gaps. There will be statewide report-outs, to see how different regions would respond, following the regional breakout. The flyer and registration information have been emailed to the Alliance membership and have been posted to the Alliance website.

### PER-320 Course

Staff report they have finalized with TEEX the dates and registration links for this course delivery. It is a full-day, in-person training. Individuals who attend this will train on PPE, with donning and doffing and other considerations during a biological event. The course flyer with more information and registration links will be attached to the meeting minutes and is on the Alliance website.

### MEMBER REPORTS AND OPEN DISCUSSION

Hospitals – Nothing new to report. Reports their pediatric inpatient numbers have decreased, but adult inpatient numbers remain the same. Working on expediting the process (time) of EMS presenting a patient, and the hospital assuming the care of the patient.

Emergency Management – Nothing to report.

Public Health – Freda Vaughn reported the new highly infectious disease response kits are now at the Jacksonville DOH warehouse. These kits include PPE, patient care equipment, disinfectants, linens, etc., all to treat a patient with an HID. Ms. Vaughn is going to compile an inventory list and have the HCC share that with the hospitals in the region. On April 19<sup>th</sup>, there is going to be a bioterrorism training on how to package and ship category A or B infectious diseases. Additionally, they are planning to provide refresher training on packaging/paperwork of white substances/bioterrorism substances.

EMS – Continues to have issues related to truck shortages. ACFR was supposed to get 5 truck chassis this month, and they just found out the order was canceled.

Long-Term Care – Nothing to report.

At-Large Representatives – Nothing to report.

The Center for Independent Living is holding an Emergency Preparedness Expo in Gainesville at Santa Fe College on April 14<sup>th</sup>. There are still spots available for individuals to attend. The Expo flyer has been sent to the membership and will be attached to the minutes.

### **CLOSING REMARKS AND ADJOURN**

The Secretary/Treasurer announced the next meeting will be an in-person, General Membership Meeting on April 26, 2023, at 1:30 at Haven Hospice in Gainesville or via Zoom.

# Personal Protective Measures for Biological Events PER-320

Personal Protective Measures for Biological Events (PPMB) is a one-day course focusing on the challenges faced by first responders and clinical health care professionals in pre-hospital and hospital environments as they deal with personal protective equipment (PPE) needs and potential contamination issues while dealing with highly infectious diseases. The course provides students with an overview of PPE, and includes experiential learning activities on donning and doffing PPE and technical decontamination. Additionally, students review the different types of decontamination.

# **FEMA SID Guide**

## **FEMA Student Identification (SID)**

### What is a FEMA SID?

FEMA Student Identification (SID) number is a unique number generated and assigned to anyone who needs or is required to take training provided by a FEMA organization. Your FEMA SID uniquely identifies you throughout the FEMA organization and all of its agencies. The goal is for your FEMA SID to serve as your personal identification number instead of your Social Security Number (SSN) in support of FEMA's effort to decrease/cease the use of SSN for identifying and tracking individuals.

### Why do I need a FEMA SID?

A FEMA SID is required to register for and participate in any training provided by FEMA. All FEMA training providers' registration systems and enrollment procedures require a valid FEMA SID. The FEMA SID will serve as your unique identifier and be used to maintain the record of FEMA training you attended.

### Do you have a FEMA Student Identification (SID) Number?

To register, go to the <u>FEMA Student Identification System</u>
Select "Register for a FEMA SID" in the middle of the screen. Follow the instructions and provide the necessary information to create your account. If you are a user with a Personal Identity Verification (PIV) card, enter your FEMA SID and select your certificate and enter your pin.

### Forgot your FEMA SID?

If you already have a FEMA SID but forgot it, go to the <u>FEMA Student</u>
<u>Identification System</u> and select the option: "Forgot Your FEMA SID." You will be asked to provide certain information. Your FEMA SID will be emailed to you along with a separate message that will ask you to reset your password.
